Mr. Jesse Barton asked for this matter to be placed on the agenda. Mr. Ricky Carter Sr. is planning on retiring August 1, 2023. Mr. Ricky Carter Sr. placed an ad on Indeed stating the District is looking to hire a person for the position of a heavy equipment operator. The Board decided to revisit this matter at the March 21, 2023 meeting.
